### BYLAW NO. 3-2018

## BEING A BYLAW TO AMEND TRAFFIC BYLAW # 4-2017 FOR THE VILLAGE OF HOLDEN

**WHEREAS** the *Traffic Safety Act* R.S.A. 2000, c. T-6, as amended or repealed and replaced from time to time, authorizes a municipal council to pass Bylaws not inconsistent with the *Traffic Safety Act,* respecting Highways under its direction, control and management, for the regulation and control of traffic within the boundaries of the Municipality;

**AND WHEREAS**, It is deemed necessary to amend Schedule C to clarify Seasonal Truck Routes in Traffic Bylaw No. 4-2017.

**NOW THEREFORE**, the Council of the Village of Holden, duly assembled, **ENACTS** as follows:

That Bylaw No. 4-2017 and amendments, thereto, of the Village of Holden, be and is hereby amended by deleting Schedule "C" in it's entirety and replacing it with the following Schedule "C"

Add:

The Village of Holden will utilize road bans, including annual spring road bans, to protect roads.

Seasonal weights for truck routes will be posted; allowable weights will range between 50% to 100 %.

### **Seasonal Weights**

Seasonal weights for heavy haul are set according to the following schedule:

- Spring weather dependent, subject to thaw depth readings of at least 25 centimeters
- Post-Thaw: June 16 (may begin one week earlier or one week later)
- Summer: July 1
- Fall: September 1
- Winter: weather dependent, subject to frost depth readings of 75 centimeters or more

Frost and thaw depths are monitored from a network of 68 electronic thermistors throughout the province and used to determine the start of spring seasons, winter seasons and placement for thaw or frost line. Information on this can be found at http://www.transportation.alberta.ca

# EFFECTIVE DATE AND BYLAW SCHEDULE "C" REPEALED

READ A THIRD TIME and passed this 20 day of February, 2018



# Schedule "C" - Truck Routes

Truck Routes are established on the following Roadways:

- 50 Street
- 51 Avenue; from Highway 855 to 50 Street
- 47 Avenue

Seasonal weights for truck routes will be posted; allowable weights will range between 50% to 100 %.

### **Seasonal Weights**
