

**REVISED BYLAW NO. 4-2025**

**A BYLAW OF THE VILLAGE OF HOLDEN, IN THE PROVINCE OF ALBERTA, TO ESTABLISH AN  
ALTERNATE METHOD FOR ADVERTISING INFORMATION REQUIRED UNDER SECTION 606 OF  
THE MUNICIPAL GOVERNMENT ACT**

**PURPOSE:** A bylaw of the Village of Holden in the Province of Alberta to set the expectations for advertising information as required under section 606 of the Municipal Government Act.

**WHEREAS,** pursuant to section 606 of the Municipal Government Act, a council must give notice of certain bylaws, resolutions, meetings, public hearings or tother things by advertising in a newspaper or other publication circulating in the area, mailing or delivering a notice to every residence in the affected area or by another method provided for in the bylaw under section 606(1); and

**WHEREAS,** pursuant to section 606.1(1) of the Municipal Government Act, a council may, by bylaw, provide for one or more methods, which may include electronic means, for advertising proposed bylaws, resolutions, meetings, public hearings and other things referred to in section 606; and

**WHEREAS,** council is satisfied that the advertising method set out in this bylaw is likely to bring matters advertised by that method to the attention of substantially all residents in the area to which the bylaw, resolution or other thing relates or in which the meeting or hearing is to be held.

**NOW THEREFORE, the Council of the Village of Holden, in regular meeting, duly assembled, hereby enacts as follows:**

**1. NAME**

This Bylaw may be cited as the "Village Advertising Bylaw."

**2. COMMUNICATION METHOD**

- a. Any information required to be advertised under section 606 of the Municipal Government Act of a bylaw, resolution, meeting, public hearing or other thing shall be given, in accordance with the timelines prescribed in section 606;
  - a) Electronically, by publishing those notices on the Village of Holden Website, [www.holden.ca](http://www.holden.ca)

**3. The Village may also communicate the information in addition to the means outlined in 2(a) using one, or more, of the following methods:**

- a. Newspaper Advertising;
- b. Posting to one or more of the Village of Holden's corporate social media channels;
- c. The Holden Times;
- d. Mailing or delivering the information to every residence in the area to which the proposed bylaw, resolution or other thing is related, or in which the meeting or hearing is to be held; or
- e. Any other means determined appropriate by the Village Council.

**4. EFFECTIVE DATE OF BYLAW**

This bylaw takes effect as of the date of third and final reading.

**READ A FIRST TIME** this 22 day of April, 2025

**READ A SECOND TIME** this 20 day of May, 2025

READ A THIRD TIME and passed this 20 day of May, 2025
